Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the 2nd Floor Board Room on Monday, March 4, 2024, at **2:03** p.m., Chairperson Robert Durrah, Jr. presiding.

Vice Chair Catherine Jourdan led the Pledge of Allegiance.

Approval of Meeting Minutes

Tricia Starkey, Board Clerk, asked that the board table this agenda item until a future meeting. Secretary Doomy moved to table the approval of the meeting minutes; Member Harvey seconded. **Motion carried unanimously.**

Approval of Absentee Ballots

Director Tim Tsujii presented to the Board a total of 411 absentee ballots for approval of which 404 are civilian ballots, 1 is a military ballot, and 6 are overseas ballots; and a total of 14 civilian ballots for disapproval. Vice Chair Jourdan moved to accept the 411 approved ballots and to disapprove 14 ballots; Member Harvey seconded. **Motion carried unanimously.**

Board members signed absentee voter reports for the approved and disapproval ballots.

Appointment of Precinct Officials for the 2024 Primary Election

Isaac Westfall, Elections Trainer, presented the Board with the current list of precinct officials for appointment in the primary election. Chairperson Durrah called for a motion to approve the list of precinct officials. Secretary Doomy moved to accept the appointment of the precinct officials as presented; Vice Chair Jourdan seconded. **Motion carried unanimously.**

Appointment of Observers List for the 2024 Primary Election

Director Tsujii presented to the board the observer lists for the primary election day, March 5, 2024.

Other Businesses

- 1. Director Tsujii presented to the Board that a registered voter cast their ballot at the WSSU-Anderson Center early voting site and stated they had mismarked the ballot. Instead of waiting for a new ballot the individual threw their ballot away and walked away. The ballot was duplicated to be processed.
- 2. Director Tsujii presented that a same-day registrant at the Southside Library early voting site was still on felony probation and that the individuals rights had not been fully restored yet. Chairperson Durrah called for a motion to challenge. Member Doomy moved to enter a voter challenge for the individual; Member Harvey seconded. **Motion carried unanimously.**
- 3. Director Tsujii presented that a registered voter at the Clemmons Library early voting site stated their party affiliation differently than how they are registered. The individual wanted to change their party affiliation, however the deadline for changing party affiliation has already passed. The individual voted a ballot which was not allowed. Member Harvey motioned to challenge the voter; Member Doomy seconded. **Motion carried unanimously.**
